

Meeting Minutes

Summary:

1. Purpose of the meeting:

This consultation round was organized as part of the project "Building Institutional Capacities to prepare for Recovery and Reconstruction in Yemen", jointly implemented by the ISDB and the OECD. The main purpose of the meeting could be summarized as follow:

- Presentation of the main findings of the OECD surveys
- Presentation of the structure of the strategic framework document in preparation by the OECD for the GoY
- Presentation of the capacity building programme to be implemented by the OECD at central level
- Presentation of the capacity building programme to be implemented by IsDB at local level

2. Main outcomes of the meeting:

- The GoY highlighted the need to better focus on Youth and Women.
- The GoY requested support to develop an institutionalized mechanisms of coordination for project implementation and support to the public service delivery (included in the Strategic framework document).
- The GoY requested support in the elaboration of a long-term development strategy for 2030 along with a comprehensive reconstruction plan for local and central authorities.
- The need to review the legislative framework of local authorities (70+ laws and regulation, often with contradictions).
- The need to better raise the awareness of youth, women, and vulnerable groups on the National Dialogue Outcomes.
