our growing CONNEX partner network: In particular, thanks to you, Stephen Karangizi and your team from the African Legal Support Facility, for your continued cooperation and your valuable support and advice. Thanks also to you, Estherine Fotabong and your team from the NEPAD Planning and Coordination Agency, for organizing another Regional Dialogue on contract negotiation and fiscal policies in the extractive industry with us! Finally, I am happy to announce that the CONNEX Support Unit will very soon conclude a

Memorandum of Understanding with the International Senior Lawyers Project for improving the cooperation among each other and better coordinating respective activities.
