



Consumption Tax Trends* - Ireland

VAT rate 2022


The Irish standard VAT rate is 23.0%, which is above the OECD average. The average VAT/GST¹ standard rate in the OECD was 19.2% as of 31 December 2022. The previous standard VAT rate in Ireland was 21% in 2020. It changed to the current level in 2021. Ireland applies reduced VAT rates of 0%, 4.8%, 9% and 13.5% to a number of goods and services. Temporary specific reduced VAT rates applied in the context of the Covid-19 pandemic until December 2022. Temporary specific reduced rates were also introduced in 2022 to counter raising energy costs. VAT was introduced in Ireland in 1972 at a standard rate of 16.37%. Since then the minimum and maximum standard rates have been at 20.00% and 30.0% respectively. The standard VAT rate was reduced from 23% to 21% from 1 September 2020 to 28 February 2021 in the context of the Covid-19 pandemic.

VAT Revenue Ratio

The VAT Revenue Ratio (VRR) for Ireland was 0.45 in 2020, below the OECD average of 0.56. The VRR is a measure of the revenue raising performance of a VAT system. A ratio of 1 would reflect a VAT system that applies a single VAT rate to a comprehensive base of all expenditure on goods and services consumed in an economy - with perfect enforcement of the tax. The Irish VRR decreased from 0.49 in 2018 to 0.45 in 2020. The lowest VRR was recorded in the year 1990 at 0.39 and the highest level in 2006 at 0.67.



The International VAT/GST Guidelines present a set of internationally agreed standards and recommended approaches to address the issues that arise from the uncoordinated application of national VAT systems in the context of international trade.

They focus in particular on trade in services and intangibles, which poses increasingly important challenges for the design and operation of VAT systems worldwide.

They notably include the recommended principles and mechanisms to address the challenges for the collection of VAT on cross-border sales of digital products that had been identified in the context of the OECD/G20 Project on Base and Erosion and Profit Shifting (the BEPS Project).
