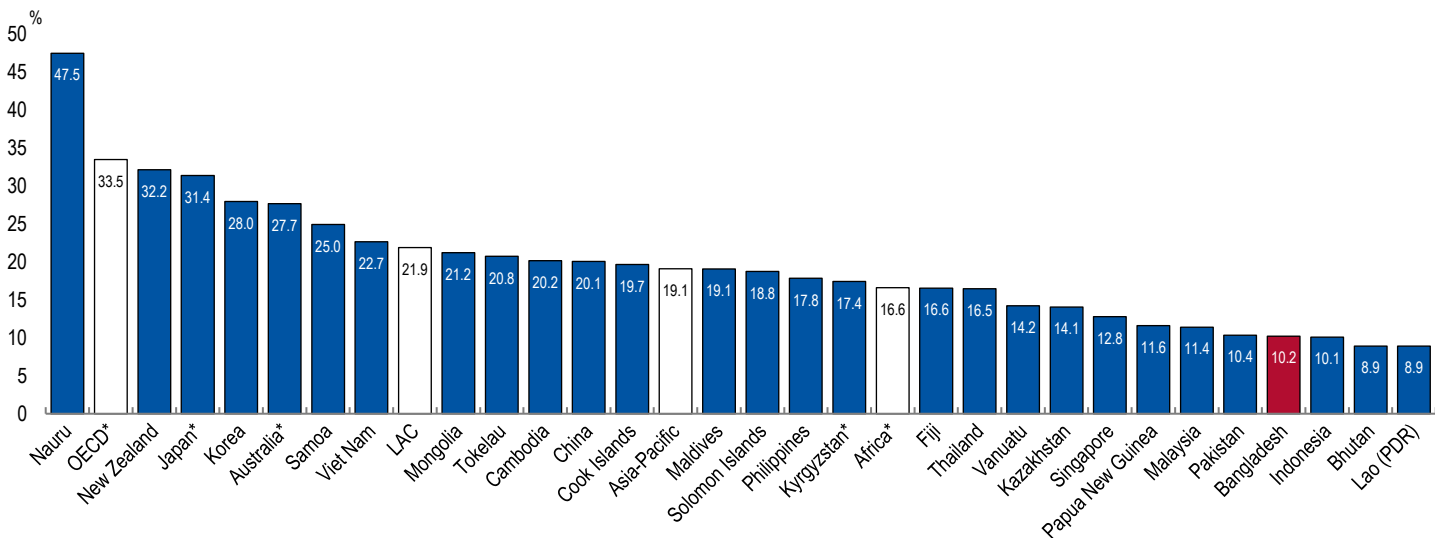


Revenue Statistics in Asia and the Pacific 2022 – Bangladesh

Tax-to-GDP ratio

Tax-to-GDP ratio compared to other Asian and Pacific economies and regional averages, 2020

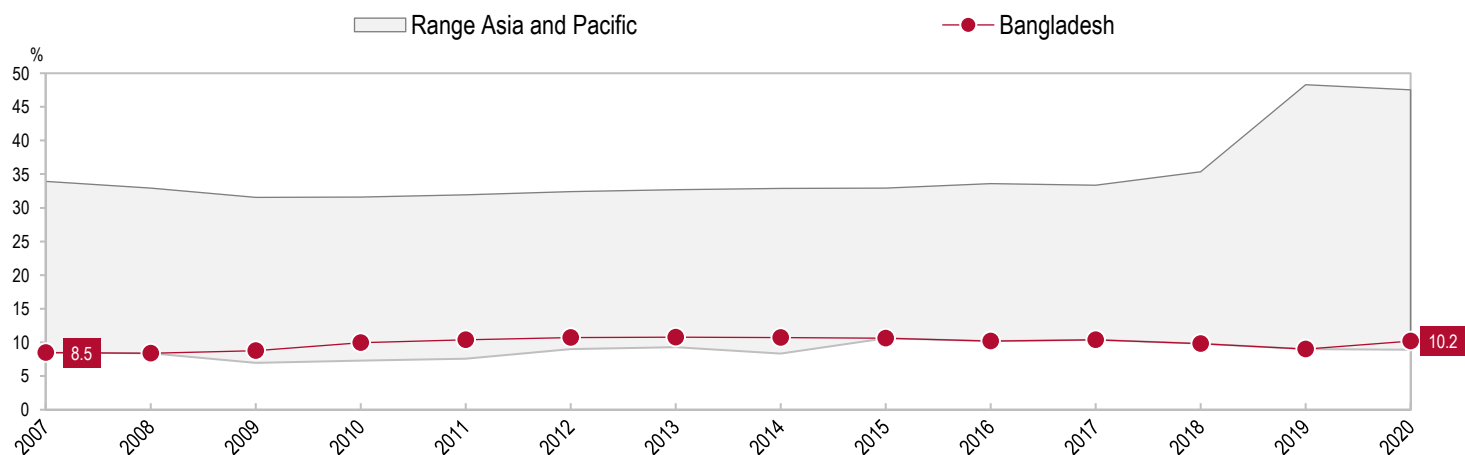
Bangladesh's tax-to-GDP ratio was 10.2% in 2020, below the Asia and Pacific (28) average of 19.1% by 8.9 percentage points. It was also below the OECD average (33.5%) by 23.3 percentage points.



* The 2019 Africa (30) average is shown. The 2020 average for Asia-Pacific (28) and the OECD is calculated using 2019 data for Australia and Japan. For Australia and Japan the 2019 data are shown as 2020 data are not available. Note by the ADB: The ADB recognises "Kyrgyzstan" as the "Kyrgyz Republic".

Tax-to-GDP ratio over time

The tax-to-GDP ratio in Bangladesh increased by 1.2 percentage points from 9.0% in 2019 to 10.2% in 2020. From 2007 to 2020, the tax-to-GDP ratio in Bangladesh increased by 1.7 percentage points from 8.5% to 10.2%. The highest tax-to-GDP ratio in this period was 10.8% in 2013, and the lowest 8.4% in 2008.



In the OECD classification the term "taxes" is confined to compulsory unrequited payments to general government. Taxes are unrequited in the sense that benefits provided by government to taxpayers are not normally in proportion to their payments. <http://www.oecd.org/tax/tax-policy/oecd-classification-taxes-interpretative-guide.pdf>

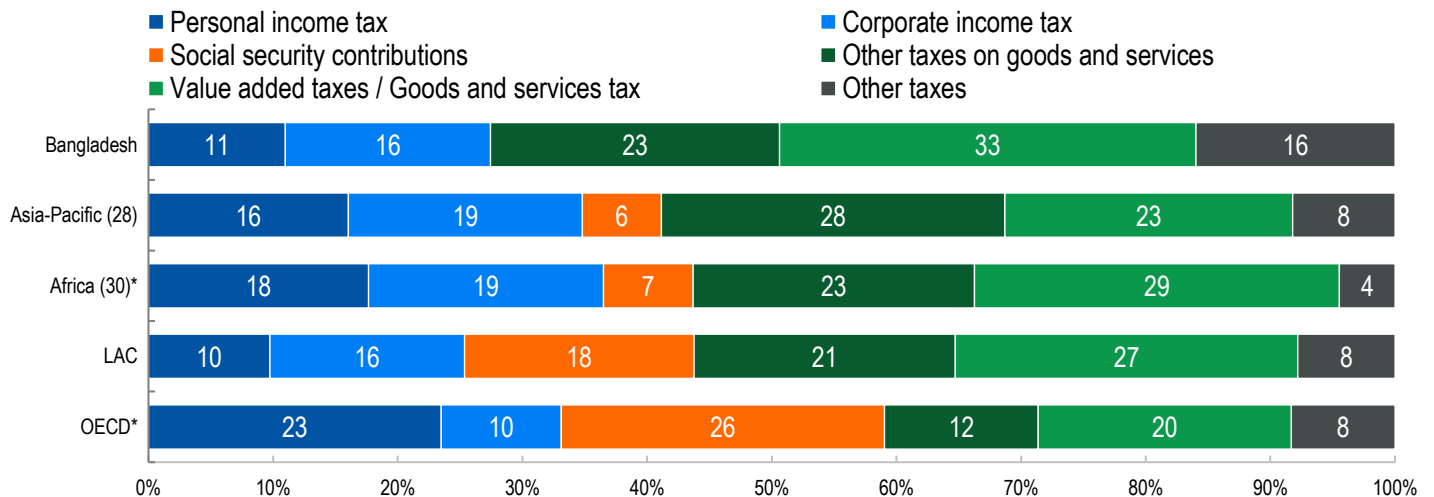

Tax structures

Tax structure compared to the regional averages

Tax structure refers to the share of each tax in total tax revenues. The highest share of tax revenues in Bangladesh in 2020 was derived from value added taxes / goods and services tax (33.4%). The second-highest share of tax revenues in 2020 was derived from other taxes on goods and services (23.2%).



* Data for 2019 are used for the Africa (30) average. The 2019 OECD average is used as Australia and Japan 2020 data are not available.

In this country note, "other taxes" is calculated as total tax minus taxes on income, profits and capital gains, social security contributions and taxes on goods and services. It includes taxes on payroll and workforce, taxes on property and other taxes (as defined in the OECD Interpretative Guide).
