The STDF supports developing countries to develop and implement projects that build SPS capactiy and help the countries to gain and maintain trade. Responsibility for SPS issues is shared among different government agencies, but the private sector also plays a role. The STDF encourages projects that seek to enhance public-private sector coordination. Research work of the STDF in 2010, in collaboration with the Inter-American Development Bank, analyses the emergence, operation, and performance of selected SPS-related partnerships between government agencies responsible for food safety, animal and plant health and/or trade and the private sector.
