

SUPPORTING ITF'S WORKSTREAM ON SUSTAINABILITY

MARKET CONSULTATION

SUMMARY:

The Organisation for Economic Co-operation and Development (OECD) is launching this Market Consultation with the objective of identifying one (1) or several experienced consultants to support the ITF's Programme of Work and Voluntary Contribution-based Projects as required, offering expertise, conducting research, and delivering strategic guidance aligned with the objectives of these projects.

Expert profile

The profile sought with this Market Consultation is for experts in sustainability applied to the transport and mobility field. The consultants are expected to perform comprehensive research, analysis, and advisory services covering the following areas:

- Conducting in-depth studies on sustainable transport policies and practices.
- Assessing the environmental impacts of transport systems and proposing mitigation measures.
- Analysing socio-economic factors influencing the adoption of sustainable mobility solutions.
- Analysing the potential impacts of sustainability policies on inclusion and equity.
- Developing strategies for accelerating the adoption of renewable energy in the transport sector.
- Developing strategies for implementing sustainability policies in the transport sector.
- Evaluating the effectiveness of existing and future sustainability initiatives in the transport sector.
- Providing recommendations for enhancing the sustainability performance of transport systems at local, regional, and global levels.
- Conducting research on adaptation and resilience strategies for transport systems in the face of climate change and other environmental challenges.
- Investigating funding strategies and financial mechanisms for delivering climate goals in the transport sector.

Bidders should clearly indicate that the proposed prices are valid for the entire duration of the project/contract (up to 4 years).



The consultants will support the ITF's Programme of Work and Voluntary Contribution-based Projects as required. This involves offering expertise, conducting research, and delivering strategic guidance aligned with the objectives of these projects. They will address specific needs identified by the ITF, utilising their sustainability knowledge in the transport and mobility sector to contribute effectively to ongoing and upcoming projects.

The timeline of the project is contingent upon its nature and complexity, typically ranging from 6 to 18 months. The specific duration will be determined based on factors such as the scope of work, research objectives, and availability of resources. The number of tasks to be initiated with the consultants and the deadlines for key activities and deliverables will be established through the agreement between the consultants and ITF's project managers within the framework contract.

How to apply

Bidders interested in participating in this Market Consultation shall provide:

- A full CV of the proposed expert.
- A cover letter (maximum two pages) outlining the consultant's previous experiences in leading or supporting policy-focused research and analysis within the sustainable transport domain.
- Examples of reports or study outputs from previous projects, demonstrating the consultant's ability to deliver high-quality and impactful research within the sustainable transport domain.
- The daily rate(s) of the expert(s).
