Preface / Introduction

This Evaluation Program is a compilation of SDC's evaluations completed in 2010 and those planned for 2011-2012. It covers the evaluations commissioned by SDC's Corporate Controlling Section, which reflect the priorities of Senior Management, and those commissioned in SDC's operational departments.

The synthesis of the evaluations conducted in 2010 and the lists in this Evaluation Programme show the number and the distribution of the planned and implemented evaluations. This programme is a rolling one and there may be changes depending on emerging needs and operational circumstances. Although there may be changes in the total number of actually implemented evaluations, this document provides relevant information on evaluation trends in SDC.

This document is produced annually in English. English is chosen because the programme is an information tool not only for stakeholders in Switzerland but also for the international development community. It is hoped that the rolling nature of the program over a two year time span will help increase the number of joint evaluations as well as promote synergies and learning processes within SDC, with SDC's partners and within the development community at large.

Through its evaluations, SDC aims to render accountability and to learn in order to improve the effectiveness and efficiency of development cooperation. This programme demonstrates to the Swiss constituency, other development actors and partners SDC's implementation of Art. 170 of the Swiss Constitution which demands that the Offices of the Swiss Federal Government regularly evaluate the effectiveness of their activities.

This Evaluation Programme reports on SDC's two main evaluation categories:

Independent Evaluation (IE) These evaluations are mandated by SDC's Senior Management to address internal strategic needs and are commissioned by the Corporate Controlling Section which is outside of line management. These evaluations are primarily summative in nature and aim to determine what was effective, what wasn't and why at the outcome / impact levels. A Core Learning Group is constituted to accompany the evaluation in order to promote learning and the implementation of agreed recommendations. SDC's Directorate commits to follow-up actions in its Senior Management Response.

Reviews: These evaluations are mandated by those directly or indirectly responsible for the planning and monitoring of a programme or project at headquarters or in SDC's cooperation offices in partner countries. They are primarily formative in nature with a focus on improving performance by analysing the factors contributing to or hindering the achievement of intended goals. SDC management at the level appropriate for the context of the review commits to follow-up actions in a Management Response.

For all evaluations, SDC adheres to the DAC/OECD Evaluation Standards, the standards of the Swiss Evaluation Society (SEVAL) and the standards established by the Active Learning Network for Accountability and Performance in Humanitarian Action (ALNAP). Independent evaluations are conducted by external evaluators free of conflicts of interest. SDC's Evaluation Policy provides further information on SDC's evaluation standards and processes. 1. Summary of SDC's Evaluation Activities in 2010

Looking back at SDC's evaluation activities in 2010 (page 6), SDC's Corporate Controlling Section (who is responsible for this document) concludes the following:

- As in most development agencies, improving evaluation quality remains a work in progress. Room for improvement is identified in the following areas: outcome / impact focus, evaluation methodology and utilisation of evaluation results for strategy development. In 2010-2011, the following steps have been undertaken:
 - An improved strategic planning of SDC's evaluations has been decided. This ensures adequate geographic, thematic and institutional coverage and a more direct link to the messages from Parliament.
 - SDCs evaluations adhere better to the updated evaluation policy.
 - Systematic quality assessment of independent evaluations upon completion.
 - Concept discussion on an evaluation tracking system to ensure easy access to evaluation reports and monitoring of management response implementation.
- In addition, SDC has been investing significantly towards "managing for development results." As planning and monitoring become increasingly results oriented, it is expected that evaluation quality will improve as well.
- The number of evaluations conducted in 2010 increased by 37% over 2009 to 143.
- The number of joint evaluations has decreased from 14% in 2009 to 6% in 2010. In 2011, 7% of the planned evaluations are planned as joint evaluations. This downward trend is indicative of the many challenges faced with regard to joint evaluations which range from identifying the right partners at the right time to dealing with the complexity of managing such processes. Engagement in such exercises needs to correspond to available resources and ability to digest the results.
- In 2010 SDC invested 0.54% of its overall budget in evaluation activities (excluding internal costs)¹. This is an increase of 0.12% over 2009. However, this remains well below the target of 0.6-0.8% set by SDC's Directorate.
- There is strong evidence that evaluation results lead to change in SDC (e.g. actions taken on the management responses). SDC will continue working towards making more systematic use and improve communication of its evaluation results.

¹ This statistic is derived from an estimate based on the assumption that the average cost of IE is CHF 220'000 and that of a review between CHF 50'000 and 100'000.

2. Summary of SDC's planned Evaluation Activities in 2011-2012

For the year 2011, 165 evaluations are planned. This is about the same number as for 2010.

- In 2011, the Corporate Controlling Section will complete four IEs. The Corporate Controlling Section is also active in joint evaluations at the level of the international development community. In 2010/2011, it is participating in the Joint Evaluation of the Paris Declaration II as a member of the International Reference Group and supporting the Benin Country Study as well as contributing to the core fund of the evaluation.
- The bulk of SDC's evaluations continue to be conducted in the operational departments (Regional Cooperation (RC), Cooperation with Eastern Europe (O), Humanitarian Aid and SHA (H)). The Global Cooperation Department (GC) contains the newly developing global programs (water, climate change, food security, migration) and reports an increase in evaluation activity from 6 in 2010 to 13 in 2011.
- In 2011, of the 165 planned evaluations, 9 or approx. 6.3% are joint evaluations down from 14 % in 2009 and 9.8% in 2010. Nevertheless this downward trend needs due attention.
