



Summary of key findings

Official statistical definition of homelessness (Table 1.HUN)

In Hungary, homelessness is defined as persons without any registered place of residence, except for persons whose registered places of residence are accommodation for homeless people. In addition, any person shall be deemed to be homeless who spends nights in public areas or premises not designed for housing purposes.

Latest national estimates of homelessness (Table 2.HUN)

The exact number of people experiencing homelessness in Hungary is not known.

Legal framework to collect data on homelessness (Table 3.HUN)

There is no legal obligation to collect data on homelessness in Hungary.

National homelessness strategy (Table 4.HUN)

Hungary does not have a national homelessness strategy.

Approaches to collect data on homelessness (Table 5.HUN)

- Registry of users (KENYSZI): Clients of homelessness services are recorded in a registry (Table 5.1.HUN)
- Service Register (MŰKENG): The number of spaces in shelters for people experiencing homelessness is recorded (Table 5.2.HUN)
