Ms. Abdel-Magied is a mechanical engineer, social advocate, writer and 'petrol head'. Debut author at 24 with the coming-of-age-memoir, Yassmin's Story, the 2015 Queensland Young Australian of the Year advocates for the empowerment of youth, women and those from racially, culturally and linguistically diverse backgrounds. Ms. Abdel-Magied is passionate about making 'diversity' the norm. At age 16, she founded Youth Without Borders, an organisation that empowers young people to realise their full potential through collaborative, community based programs. She was named one of Australia's most influential engineers by Engineers Australia, and has been recognised for her work in diversity by the United Kingdom's Institute of Mechanical Engineers. The youngest woman named in Australia's 100 Women of Influence by the Australian Financial Review in 2012, Ms. Abdel-Magied was the Young Muslim of the Year in 2007 and Muslim Youth of the Year in 2015. A sought-after advisor for federal governments and international bodies, she currently sits on the Boards of ChildFund, The Council for Australian-Arab Relations (CAAR) and the domestic violence prevention organisation, OurWatch. She is the Gender Ambassador for the Inter-American Development Bank and has represented Australia through multiple diplomatic programs across the globe. You can also find Ms. Abdel-Magied presenting on TV, currently hosting ABC's weekly show, Australia Wide. She is a regular on Q&A, The Drum, The Project, and internationally on the BBC. She was educated at the University of Dublin (Trinity College). King's Inns Dublin and Harvard Law School to which she won a fellowship in 1967. As an academic (Trinity College Law Faculty 1968-90), legislator (Member of the Irish Senate 1969-89) and barrister (Irish Bar 1967-90, Senior Counsel 1980; called to the English Bar 1973) she sought to use law as an instrument for social change, arguing landmark cases before the European Court of Human Rights and the European Court in Luxembourg as well as in the Irish courts. A committed European, she also served on expert European Community and Irish parliamentary committees. In 1988 Mary Robinson and her husband founded the Irish Centre for European Law at Trinity College. Ten years later she was elected Chancellor of the University. The recipient of numerous honours and awards throughout the world including the Presidential Medal of Freedom from President Obama, Mary Robinson is a member of the Elders, former Chair of the Council of Women World Leaders and a member of the Club of Madrid. She serves on several boards including the European Climate Foundation, the Mo Ibrahim Foundation, and is a member of the Royal Irish Academy and the American Philosophical Society.

She now serves as President of the Mary Robinson Foundation – Climate Justice. Mary Robinson was the UN Secretary-General Special Envoy to the Great Lakes Region of Africa and served as the UN Secretary-General's Special Envoy on Climate Change. In May 2016 the UN Secretary-General appointed Mary Robinson as a Special Envoy on El Niño and Climate.

Trumka joined an insurgent campaign and was elected secretarytreasurer of the AFL-CIO in 1995. He became the federation's president in 2009.

The Legal Unit, which consists of 180 experts, lawyers and planners, takes care of all of the legislation work and business processes for numerous benefits implemented by Kela.



After quitting the VPRO he accepted the offer to become the next editor-in-chief of Z! the Amsterdam street paper (homeless paper). As some said: 'working for Z! meant a breakthrough to a smaller audience for Van Dalfsen.' From the start managing Z! was a challenge because after 2008 the economy was on a downward slope and the people in the streets of Amsterdam had less and less cash in their pockets. For this reason Z! did a test with cashless payments in 2016 by giving a group of vendors a potable pin machine. The test proved that Z! was ahead of its time. Consequently Z! decided to postpone its ambition to offer its homeless vendors a cashless payments system until the fin tech community has caught up.
