<b>OECD Programme</b>	<p>Programme for Teaching and Learning International Survey (TALIS)</p> <p>TALIS is a Part II Programme with the overall goal of filling key international and national data gaps on teachers, their professional development, teaching, the learning environment and the impact that teachers can have on students. TALIS' general purpose is to provide comparative data and analysis to help with the development of teaching as a profession, aimed at supporting the learning of students. <b>Criteria for participating in TALIS</b>	<p>There are two types of criteria for establishing the list of TALIS participating countries:</p> <ol style="list-style-type: none"> <li>1) Mutual benefit for the Programme and the Partner.</li> <li>2) Technical, organisational and financial capacity to undertake the survey.</li> </ol>
<b>Possible status in the TALIS GB</b>	<p><b>1) <u>TALIS GB members</u></b></p> <p>The decision to invite a Partner as a TALIS GB member is taken by the OECD Council following a recommendation of the TALIS GB. It is an open-ended invitation. A Partner invited as a TALIS GB member participates on an equal footing with OECD Members. TALIS GB members only participate in decisions related to the modules in which they participate.</p> <p><b>2) <u>TALIS GB observers</u></b></p> <p>The decision to invite a Partner as a TALIS GB observer is taken by the TALIS GB. The invitation is for the duration of the cycle. TALIS GB observers actively participate in the work of the TALIS GB, but do not participate in decision making.</p>
<b>Financial contributions</b>	<p><b>1) <u>TALIS GB members</u></b></p> <p>The scale of contributions for TALIS, attributed to TALIS GB members or their sub-national entities as applicable, shall be composed of:</p> <ul style="list-style-type: none"> <li>• A <b>floor contribution</b> to be determined by the TALIS Governing Board; and</li> </ul>

- The **remainder of budget** to be assigned on the basis of the OECD principles and rules for determining the scales of contributions by Members other than for Part I of the Budget of the Organisation, using as input statistics the national income data and exchange rates used in the calculation of scales for the previous year.

In the case of sub-national entities:

- The adjustment to the national income and population data for determining their share in the scale of contributions other than the floor contribution shall be their country's taxable income multiplied by the average percentage of the country's gross domestic product represented by the sub-national entities over the relevant three year period. The source of data used shall be the relevant national statistical office;
- When several sub-national entities from a given country participate jointly in TALIS, they would only pay the floor contribution once. When each sub-national entity participates independently, they would pay its own floor contribution.

2) **TALIS GB observers** shall pay an amount equal to the **floor contribution**.
