▪ **Trust in government**

In many advanced economies rising inequalities and disparities in regional economic performance, notably among urban and rural areas, appear to be met with rising citizen mistrust in government and institutions. The COVID-19 pandemic risks exacerbating the disparities given its asymmetric socio-economic impact. Meanwhile, trust in government has been crucial to generating compliance with containment measures, vaccine acceptance and successfully managing the crisis. Understanding regional and local drivers of trust in government can help policymakers better tackle the underlying sources of declining trust and design targeted strategies for a resilient recovery.

▪ **About the event**

The webinar will explore what is driving the regional divides of trust in government and assess current measurement challenges. Speakers will discuss emerging markers of trust in government in different types of regions, and policy solutions to address the trust divide, particularly among urban and rural areas.

The webinar will delve into which local characteristics and socio-economic conditions can influence trust in government. Attention will also be placed on the importance of place-based policies and multi-level governance mechanisms in addressing the underlying determinants of trust and mistrust.

▪ **Background**

This webinar is part of a new project being launched by the OECD's Centre for Entrepreneurship, SMEs, Regions and Cities (CFE) to explore the territorial dimensions of trust in government. It is organised in partnership with the OECD Public Governance Directorate (GOV) as part of the broader OECD work on the drivers of trust in government and public institutions. This OECD webinar brings together experts from around the world to build the knowledge base and promote international dialogue on this issue.
