
THE OECD EXPERIENCE

DEFINING THE CONCEPTS

TERM	DEFINITION	
Values	General moral obligations. The core beliefs we hold regarding what is right and fair in terms of our actions and our interactions with others. Another way to characterize values is that they are what an individual believes to be of worth and importance to their life (valuable). Example: Integrity.	
Principles	Ethical conditions or behaviours expected from an individual. Principles are derived from values. Example: Do not use your public office for private gain.	
Ethics	The study of what we understand to be good and right behaviour and how people make those judgments.	
Ethics Code	Document intending to articulate the values and principles expected of decision makers when confronting unclear or ambiguous ethical circumstances. Often conveys organizational values, a commitment to standards, and communicates a set of ideals. In practice, used interchangeably with Code of Conduct.	
Code of Conduct	Document designed to anticipate and prevent certain specific types of behaviours. Can refer to a listing of required behaviours, the violation of which would result in disciplinary action. In practice, used interchangeably with Code of Ethics. Codes of conduct in the education sector, in accordance with UNESCO's definition, embrace the concept of mutual accountability and the accountability of all those charged with enabling good quality education	
Code of Behaviour	Term used interchangeably with Code of Conduct or Ethics Code.	
Principles of Social Responsibility	A framework of measurable corporate policies and procedures and resulting behaviour designed to benefit the workplace and, by extension, the individual, the organization, and the community.



A LIMITED INTEREST?

- Ethical guidelines for management and governance of HEIs are useless or very difficult to implement.
 - · Too general and vague
 - · Important contextual, historical and political differences
 - · Private vs. public
 - No enforcement measures
 - · Good intentions, crude realities
 - · The human factor
- Emerging complicated dilemmas in institutional decision making processes make urgent to develop guidelines
 - Universities are no longer isolated institutions
 - Institutional leaders facing uncertainty, conflict, ethical dilemmas, increased pressures for openness and transparency, corruption, etc.








SOME POSSIBILITIES

- Metrics, evaluation, and incentives


