

Consumption Tax Trends* - Sweden

VAT rate 2022


The Swedish standard VAT rate is 25.0%, which is above the OECD average. The average VAT/GST¹ standard rate in the OECD was 19.2% as of 31 December 2022. The previous standard VAT rate in Sweden was 23.46% in 1989. It changed to the current level in 1990. Sweden applies reduced VAT rates of 0%, 6% and 12% to a number of goods and services. Temporary specific reduced VAT rates applied in the context of the Covid-19 pandemic from January 2020 to June 2022. VAT was introduced in Sweden in 1969 at a standard rate of 11.11%. Since then the minimum and maximum standard rates have been at 17.65% and 25.0% respectively.

VAT Revenue Ratio

The VAT Revenue Ratio (VRR) for Sweden was 0.60 in 2020, above the OECD average of 0.56. The VRR is a measure of the revenue raising performance of a VAT system. A ratio of 1 would reflect a VAT system that applies a single VAT rate to a comprehensive base of all expenditure on goods and services consumed in an economy - with perfect enforcement of the tax. The Swedish VRR increased from 0.59 in 2018 to 0.60 in 2020. The lowest VRR was recorded in the year 1992 at 0.40 and the highest level in 2020 at 0.60.

They focus in particular on trade in services and intangibles, which poses increasingly important challenges for the design and operation of VAT systems worldwide.

They notably include the recommended principles and mechanisms to address the challenges for the collection of VAT on cross-border sales of digital products that had been identified in the context of the OECD/G20 Project on Base and Erosion and Profit Shifting (the BEPS Project).
