

# **Consumption Tax Trends\* - United Kingdom**

#### VAT rate 2022


The United Kingdom's standard VAT rate is 20.0%, which is above the OECD average. The average VAT/GST¹ standard rate in the OECD was 19.2% as of 31 December 2022. The previous standard VAT rate in the United Kingdom was 17.5% in 2010. It changed to the current level in 2011. The United Kingdom applies reduced VAT rates of 0% and 5% to a number of goods and services. Temporary specific reduced VAT rates applied in the context of the Covid-19 pandemic until March 2022. VAT was introduced in United Kingdom in 1973 at a standard rate of 10.0%. Since then the minimum and maximum standard rates have been at 8.0% and 20.0% respectively.

### **VAT Revenue Ratio**

The VAT Revenue Ratio (VRR) for the United Kingdom was 0.44 in 2020, below the OECD average of 0.56. The VRR is a measure of the revenue raising performance of a VAT system. A ratio of 1 would reflect a VAT system that applies a single VAT rate to a comprehensive base of all expenditure on goods and services consumed in an economy - with perfect enforcement of the tax. The United Kingdom's VRR decreased from 0.45 in 2018 to 0.44 in 2020. The lowest VRR was recorded in the year 1993 at 0.41 and the highest level in 1991 at 0.48.

### International VAT/GST Guidelines

The International VAT/GST Guidelines present a set of internationally agreed standards and recommended approaches to address the issues that arise from the uncoordinated application of national VAT systems in the context of international trade.

They focus in particular on trade in services and intangibles, which poses increasingly important challenges for the design and operation of VAT systems worldwide.

They notably include the recommended principles and mechanisms to address the challenges for the collection of VAT on cross-border sales of digital products that had been identified in the context of the OECD/G20 Project on Base and Erosion and Profit Shifting (the BEPS Project).
